Surrender of Licence by The Nascent Fund SICAV plc

This notice is to make the general public aware that The Nascent Fund SICAV plc (“the Scheme”) recently requested the Malta Financial Services Authority (“MFSA”) to accept the surrender of the collective investment scheme licence granted in relation to LJM Preservation and Growth Fund (“the Sub-Fund”). The MFSA has accepted the Scheme’s request. This surrender is entirely voluntary and does not arise as a result of any regulatory action taken by the MFSA. Accordingly, with effect from 17 April 2015, the Sub-Fund ceased to be licensed by the MFSA.
