Surrender of Licence by SB Global Fund SICAV plc

This notice is to make the general public aware that SB Global Fund SICAV plc (“the Scheme”) recently requested the Malta Financial Services Authority (“MFSA”) to accept surrender of its collective investment scheme licence. The MFSA has accepted the Scheme’s request. This surrender is entirely voluntary and does not arise as a result of any regulatory action taken by the MFSA. Accordingly, with effect from 18th April 2012, the Scheme ceased to be licensed by the MFSA.
